Holiday City Association 2170 Yorktowne Blvd - Toms River, NJ 08753

The following changes to the Holiday City Association Phase 1, Declaration of Covenants and Restrictions, Rules, Regulations and By-Laws have been voted on and approved by the Association Homeowners. All changes are effective as of March 15, 2025. Please take the time to familiarize yourself with the changes and be sure to insert them in your copy of the Associations By-Laws.

Article II – Election and Voting Rights.

Section 1. Only owner members in the Association shall be entitled to cast one vote during any meeting or election. Any lot or living unit owned jointly by two or more persons, as husband and wife, or otherwise, shall be entitled to one vote only. (rev 03-15-2025)

Section 2. Each voting owner member of the Association during an election of Trustees shall cast one vote only for each Trustee to be elected. Votes may be cast by Official Ballot Only, either in person or by an absentee ballot, said ballots must be in writing, signed, and forwarded to the Secretary of the Association No later than the closing of the polling station. (rev 03-15.2025)

Section 3. It shall be the function of the Nominating committee to submit a reasonable number of nominees for the vacancies to be filled on the Board of Trustees. Said list of nominees shall be submitted to the Board sixty (60) days prior to the annual election. Said number of nominees shall be at least one more than the number of vacancies of said Board of Trustees. The nomination committee shall ensure that the Official Ballot lists all candidates in alphabetical order, no candidates are listed as incumbents, and that there will be space for write in votes equal to the number of seats up for election. (rev 03-15.2025)

Section 4. The Board of Trustees shall appoint an Election Committee, its purpose being to supervise the election, count the ballots, notify all candidates of the results, and only after all candidates are notified, properly post the results. The Election Committee shall be independent of the Nominating Committee and the Board of Trustees. (rev 03-15-2025)

Section 5. The Election Committee shall ensure proper distribution of the Official Ballot with voting Instructions and resumes of all candidates. This shall be accomplished by way of the Association Newsletter, mailings directly to the owners of rental properties, The Association newsletter is only mailed to the community, not to non-resident landlords. Official Ballots, voting instructions and resumes will also be available at the Clubhouse during office hours. (rev 03-15-2025)

Section 6. (b) Each voting owner must be a member in good standing with the Holiday City Association. All votes will be validated and confirmed as eligible before being tallied. (rev 03-15-2025)

Section 6. (c) All ballots must be validated and tallied immediately following the closing of the election. The results shall be posted on the bulletin board inside the clubhouse only after all candidates are notified. (rev 03-15-2025)

Section 6. (e) A successfully elected candidate who, for one reason or another, decides not to or is unable to accept that responsibility prior to taking office shall be replaced by the candidate receiving the most votes of those candidates not considered as have won the election. In the event that there are no candidates willing to accept the position, appointments shall take place in accordance with Article III, Section (a). (rev 03-15-2025)

Article III - Board of Trustees, Liability of Board of Trustees.

Section 2. The Board of Trustees shall consist of five (5) members who shall elect from among their members a chairperson who shall preside at all meetings of the Board. Candidates for the Board of Trustees shall be owner members in good standing. You must have resided in the Community for two (2) years prior to the election and have attended two biannual meetings in the prior year. No more than one owner per household can serve as a member of the Board of Trustees. Trustees shall be elected to serve a three (3) year term and if they so desire may run again for second term, after which they will be required to wait one year for re-nomination, assuming that they are elected that second time. (rev 03-15-2025)

Section 3. (a) In case of any vacancy, the Board of Trustees shall appoint a replacement to fill the unexpired term. Appointees will first be drawn from the list of candidates not considered having won the in the most recent election, then from interested owners who meet vetting qualifications. Last to be considered are previous trustees who were ineligible to run in the last election because of term limits. (rev 03-15-2025)

Article VI – Subsequent Sales, Transfers, Gift Devisee and/or lease Agreement

Section 5. Any Owner, who is either a member or required to be a member of the association may own a second Living Unit in Holiday City Phase I, only if the following conditions are satisfied.

- (a) Must currently own and occupy a Living Unit for at least two (2) years.
- **(b)** The owner is in good standing with the association.
- (c) Complies with all the Lease Regulations set forth in this section prior to occupancy by lessee. (rev 03-15-2025)

Section 6. No owner of a lot or living unit shall lease his/her property, or any portion of, to any person or persons unless said owner has in writing made full disclosure to the Association that such prospective tenant meets all of the qualifications of membership in the Association, more specifically, but not by way of limitation, that said tenant is of the age of fifty-five (55) years or older and that no children under the age of eighteen (18) shall share his or her living unit, before the owner can enter into any lease agreement. The Association must give its consent in writing to the owner to enter into such an agreement. This clause in no way relieves the owner's responsibility under the terms of these By-laws to pay in full all monthly dues and special assessments charged by the Association against said premises. (rev 03-15-2025)

Section 6. (a) No Owner of a Living Unit may rent a Living Unit unless the Owner of the Living Unit complies with All the provisions of these lease Regulations including but not limited to renting a living unit as an Air B&B, Short Term rental or any other similar rental practices that promote short term occupancy and turnover. (rev 03-15-2025)

Section 6. (b) Proposed change - No Owner of a Living Unit, who purchases a Living Unit after the date of this Amendment, shall rent the Living Unit until the Owner has owned a Living Unit for at least two (2) years. (rev 03-15-2025)

Article V – Committees

Section 4. (f) One shed allowed, not to exceed 8 feet X 12 feet X 8 feet, must be either metal, vinyl or treated wood and anchored on a concrete slab, cement block or treated wood base and must be at least 5 feet from the foundation of the home and 3 feet from adjacent property lines. All sheds must be in compliance with Toms River Ordinances and require a Zoning Permit. (rev 03-15-2025)

BOARD OF TRUSTEE ELECTION OFFICIAL BALLOT

On Monday, May 19th, 2025, Elections for the Holiday City Association Board of Trustees will be held in the Association Clubhouse, 2170 Yorktowne Blvd. from 1:00PM to 4:00PM for the purpose of electing four (4) Trustees.

According to the association by-laws, only owners in the Association shall be entitled to cast one vote during any meeting or election. Any lot or living unit owned jointly by two or more persons, as husband and wife, or otherwise, shall be entitled to one vote only (Article II, Section I). Each voting owner must be a member in good standing with the Holiday City Association. All votes will be validated and confirmed as eligible before being tallied (Article II, Section 6. (b) & Article X).

All ballots must be returned no later than 4:00PM on Monday, May 19th, 2025, when the election process is closed! Immediately following the close of elections, the Election Committee will publicly validate and tally all votes at the clubhouse.




