## **COMMUNITY MANAGER**

Spring is in full swing, and with it comes a flurry of activity around the community! I wanted to take a moment to share a few important updates and reminders as we prepare for a great season ahead.

Landscaping: You've probably noticed the landscaping crews out and about as spring cleanup and maintenance are well underway. As a reminder, please do not approach the landscapers directly with questions or requests. All questions, concerns, or comments should be directed to the Management Office—not the workers or Board Members at their homes. This helps ensure the crews can focus on their work and stay on schedule.

**Irrigation:** Federal Irrigation started working on our systems the beginning of April and will be continuing the start-up of the irrigation system. They have been checking every head for damage, pressure, and coverage. Please give them time to complete the check before reporting any issues. During the year, these heads may need adjusting or repair. Just let the office know and a ticket will be place. Please do not attempt to make any repairs yourself.

**Power Washing:** Please do an inspection of your homes and have them power-washed if necessary. Covenants will be inspecting throughout the season. It's also a good time to inspect your homes for any damages over the winter. We have had some crazy wind storms that could cause damage to siding, vents, trim, etc.

**Pool:** As we look forward to Memorial Day, we're also excited about the pool's opening! The pool will open on Saturday, May 24<sup>th</sup>, and remain open until Labor Day, Monday, September 1st, with regular hours from 11:00 AM to 6:00 PM. This year, we're trying something new by introducing a pool monitor—please note, this is not a lifeguard, but someone to help oversee the area. More information about the monitor will be shared soon. The full

schedule of pool hours will be in the June N&V. We have the last week in May and the first week of June in this issue (May).. As we head into pool season, we kindly ask that all residents clean up after themselves, close umbrellas when leaving, and return chairs to their proper location. Please also take the time to familiarize yourself with the pool rules. Some will be posted on signs at the pool, and a full list is included in this newsletter. A few important reminders: no swimming alone-the buddy system must be used; you are responsible for your guests at all times; children under the age of 3 are never allowed in the pool; children over 3 who are still in diapers are also never permitted in the pool. Flotation devices such as kickboards, rafts, and similar items are not allowed, though noodles and child training devices like arm swimmies and back bubbles are acceptable. Let's all do our part to help make this a safe and enjoyable pool season!

**Pets:** As we continue to provide pet waste stations throughout the community, we ask that all pet owners use them responsibly. There is no excuse for not picking up after your pets—let's work together to keep our neighborhood clean and enjoyable for everyone. Please be courteous when using the stations: take only one bag if needed, not multiple. Always be sure your dog is on a leash, with the leash securely attached at all times. Your cooperation helps keep Winding Ways a safe and welcoming place for all residents.

## WINDING WAYS COVENANTS COMMITTEE

#### April, 2025

Dear Residents,

This is a reminder that the Winding Ways Covenants Committee will be conducting property inspections during the months of April and May. The purpose is to ensure that the aesthetic appearance of our beautiful community is maintained.

Appearance impacts the home values of all properties, not just the home in question---- that is the primary reason for annual inspections. The Committee will be checking for mold, as well as looking for changes that have been made without proper application and approval of the architectural committee.(i.e.,painting ,concretepainting, color changes, windows, doors, landscaping, tree/shrub removals/ additions, patio changes, unapproved fencing, etc.(in other words, obvious violations of the rules in the Rules of the Community contained in Titles I, II and III).

Should you not have copies of the titles, you can request <u>electronic copies</u> from the Management office. Hard copies, if requested, will require a \$15.00 charge (each homeowner received the Titles upon home closing). Also, please be aware that the Covenants Committee is the only committee required in our Charter. The Committee consists of volunteer residents who have been asked to work on behalf of the community. Most often, violations are brought to the attention of the office by a resident. The committee members are given the address of the possible violation only. The office notifies the Committee, and a member (members) of the Committee will inspect the residence to determine if a violation exists. If a residence is determined to be in violation, a warning will be issued; if not corrected within a specified period, a second (and if necessary), third notification will be issued. Usually, a violation is easily corrected and there is no need for a second or third warning. Failure to correct a violation could result in fines assessed to the property.

Should a homeowner wish to appeal a violation, it should be done via a letter (not a verbal conversation/request) to the board of trustees, through the Management office. (The appeal process can be found in the rules)

#### 2-5 Swimming Pool

2-5.01 <u>Hours/Dates of Operation</u>: The pool will open Memorial Day weekend and will close on Labor Day. The hours of operation at which lifeguards will and will not be present, will be set by the Board of Trustees. All dates and hours are to be published.

2-5.02 <u>Access</u>: Access to the pool area is from the North & South Entrances & will require a fob. If in wet bathing attire, please either change in the locker room or dry off before walking through the clubhouse. Shoes and Shirts MUST be worn in the clubhouse. When lifeguards are not on duty access to the pool <u>area</u> is allowed, but re-entry to clubhouse will require the use of key fob at locker-room. To exit the pool area to the parking lot, use the north gate.

2-5.03 **Guests:** Guests are allowed to use the pool only in the presence of their sponsoring resident. Residents have priority over the use of chairs. Each household is allowed to bring a maximum of four (4) guests to use the facilities at any one time. Children must be supervised by a responsible adult resident whether or not lifeguards are on duty.

2-5.04 <u>Minimum Age Requirement:</u> Only children who are three (3) years of age or older will be allowed to use the pool. 2-5.05 <u>Local & NJ State Health Regulations:</u> Local and NJ State Health Regulations shall be followed by users of the pool facilities at all times. All pool users must shower before using the pool in accordance with NJ State Health Requirements.

2-5.06 <u>Attire:</u> Proper swimming attire is required for use of the pool. Street clothes of any sort cannot be used as swim attire. Cover-ups, such as hats or tee shirts are permitted for sunburn protection.

2-5.07 <u>Conduct:</u> In addition to the conduct specified in Title II, Section 2-3.03, running or horseplay is not allowed in the pool area.

2-5.08 <u>Pool Rule Enforcement:</u> Lifeguards are authorized to enforce all rules and regulation regarding the use of swimming pool facilities. Where violations of such rules and regulations continue to occur, lifeguards shall notify their supervisor or the Community Manager or Trustee, who shall take appropriate action.

2-5.09 **Off-Hours Use:** Swimming is prohibited when lifeguards are not present. But access to the pool area is allowed. Re-entry into the clubhouse will be through the locker-rooms only and will require a fob. Exit to the parking lot will be through the north gate.



#### 2-5.10 Food/Drink:

- a. Food is allowed on deck areas around the pool but not in the pool itself.
- b. Nonalcoholic drinks are allowed anywhere on the pool deck, but must be in unbreakable plastic or metal containers. Alcoholic beverages are permitted in accordance with Title II 2-3.08. Glass containers are not permitted anywhere in the pool enclosure.
- c. Residents are responsible to make sure that the areas are kept clean and that food and drink do not get into the pool or landscape beds.

2-5.11 **Diapers:** Individuals who are not toilet trained or are in diapers or any kind of swimmies (pull-ups) are not allowed in the pools

2-5.12 **Diving or Jumping:** Diving or jumping into the pool is not allowed for safety reasons.

2-5.13 **Flotation Devices:** Flotation devices such as kick boards, rafts, etc. are not allowed in the pool area. However, noodles are allowed. Training devices for children are acceptable (such as arm swimmies and back bubbles).

2-15.14 **Pool Furniture:** Pool furniture will be used on a first come, first serve basis and residents have priority on the use of pool furniture. Furniture may not be reserved by placing towels on chairs or by any other method of reserving.

- a. Residents should lower the umbrellas when leaving the pool area or if inclement weather threatens. This is a safety request as the umbrellas can be blown over in high winds and cause property damage and or personal injury.
- b. The lifeguards are responsible for returning the pool furniture to its original settings at the beginning and end of their hours.

2-5.15 **Pool Partition**: For your own safety and the safety of other residents and guests, no one is allowed to walk on or across the partition between the main pool and the shallow pool in the pavilion area.

2-5.16 <u>Handicap Lift:</u> The handicap lift is for the use of handicapped individuals only.

2-5.17 **Baby Carriages and Strollers:** Baby carriages and strollers of any kind are not permitted in the pool area.

2-5.18 **Smoking:** Smoking & Vaping is prohibited in the entire pool area as well as recreational common areas.

2-5.19 **Baby Pools:** Plastic and inflatable kiddie pools are not permitted within the confines of the pool area.

2-5.20 **<u>Headphones:</u>** Headphones must be used with radios, etc. in the pool area.

## **ARCHITECTURAL COMMITEE**

Please remember an <u>Architectural Application</u> is needed <u>with an approval</u> from the <u>Architectural Committee</u> before any work can start. You must allow up to 21 days for approval, so plan accordingly. Applications are needed for, but not limited to:

- All shrub and tree removal/planting
- Painting house, doors, shutters, etc.
- Landscape work: Seeding, Edging, Creating/expanding beds, etc.
- Any modification to the exterior of your home & property. You can refer to Title III, Rule 2.5 of the Winding Ways Rules & Regulations for the exceptions.

Be sure to hire only licensed and insured contractors for your protection and the protection of the HOA! *It's a requirement of the HOA!* 

Also remember, when your work is complete, call the Management Office for a final inspection, which is required before your Bond can be released.

### NOTE:

The following work will require a work bond to be held in the office:



NJ State law states that "Digging of any kind, such as for; mailboxes, flagpoles, trees and large shrubs, requires a call to <u>1-800-272-1000</u> for a <u>FREE</u> mark out of the area involved" <u>The person doing the digging must make the call!</u> It is important to note that <u>Title III, Chapter 2-4 Paragraph</u> states: Homeowners shall be responsible for any damage or injury that results to any building, person or property, arising out of the installation of the subject matter of the application. Also a mark out of sprinkler heads may be required. Please call Federal Irrigation to inquire and schedule at 732-349-9905.


